Concentration is on artisans who do work in and with natural materials. This includes, but is not limited to: wood, leather, fiber arts, garden arts, soapmaking, candles, pottery, herbal crafts, glass, recycled materials, and nature art.

Original works by professional and amateur artisans. Objects made from commercial kits or commercial available plans are not acceptable.

ENTRY PROCEDURE:

Submit this application with images.

- Include four–six images representative of the work you will display. Please also submit an image of your display.
- CD with jpeg 300 dpi minimum or email allison@ah-haartsmgmt.com to arrange email or Dropbox file transfer
- Label each with artists name, media, title and price. Images should show one item clearly against a simple background

Upon acceptance you will receive a contract that will tell you all about the event's procedures and how to provide us with an inventory of the work you will be bringing. You will also receive information on how to sign up for check in/out times and to volunteer at the event.

SET UP, SALES, FEES & BOOTH INFORMATION

Merchandise check in: Wednesday, November 29, 10 am- 8 pm; Thursday, November 30, by appointment

Opening Reception/Sale: Friday, December 1, 5 pm- 8 pm for artists and Wildlands Conservancy board, staff, and guests

Sales Days/Times: Saturday, December 2, 10 am- 6 pm; Sunday, December 3, 10 am- 4 pm

Merchandise Check Out: Sunday, December 2, 4:30 pm- 8:30 pm

Fees: \$35 table reservation + 25% commission on all sales

A Registration is a commitment to the two days and official hours of the show

Participating artists must supply their own display items

Tables and covers may be provided

Spaces are approximately 6'x30"
